

Boston Pizza[®] x Molson[®] Playoff Giveaway Contest (the "Contest")

OFFICIAL RULES AND REGULATIONS

The Contest is intended for viewing and participation in Canada only by legal residents of Canada who are at least 19 years of age, and shall be subject to and construed in accordance with the laws of Canada. Please do not proceed if you do not satisfy these requirements at the time of entry. Entry into the Contest constitutes your acceptance to these Official Contest Rules and Regulations. NO PURCHASE NECESSARY.

- 1) ADMINISTRATION: The Contest is administered and operated by Boston Pizza International Inc. (the "Contest Operator"). The decisions of the Contest Operator are final and binding in all matters as they relate to the Contest, including without limitation eligibility and/or disqualification of entries. Molson Canada 2005 ("Molson") is a prize supplier only. Molson and its related companies, affiliates and subsidiaries are not responsible for the promotion, administration or execution of this Contest, or the administration, use or misuse of any prize. By entering this Contest, entrants agree to completely release Molson and its related companies, affiliates and subsidiaries from any liability.
- 2) ELIGIBILITY: To be eligible to win a prize in the Contest, you must: (i) be a legal resident of Canada; (ii) be at least 19 years of age on May 2, 2025; and (iii) not be an employee, contractor, agent or representative of (and not be a member of the immediate families of an employee, contractor, agent or representative of) the Contest Operator, Boston Pizza Canada Limited Partnership ("BPCLP"), Molson, or any of their affiliates, agencies, prize suppliers, any franchisee of BPCLP or any of their respective shareholders, trustees, directors, officers, employees or agents with whom such employees contractors, agents and representatives are domiciled. For the Facebook Winner (defined below) or Instagram Winner (defined below) not resident in Alberta, the Facebook Prize and Instagram Prize will each consist of one (1) \$100 Boston Pizza gift card (the "BP Gift Card"), one (1) Molson-branded patio heater and one (1) Molson-branded glass door fridge. For any Facebook Winner or Instagram Winner resident in Alberta, the BP Gift Card in the Facebook Prize or Instagram Prize, as applicable, will be replaced with an Amazon® gift card of equivalent value. The approximate retail value of each Facebook Prize and Instagram Prize is CAD\$1,150.00. The Facebook Prize and Instagram Prize must be accepted as awarded and has no cash value. The Facebook Prize and Instagram Prize is non-transferable, non-redeemable and no substitution will be made except that the Contest Operator, in its sole discretion, reserves the right to substitute the Facebook Prize or Instagram Prize for a prize of equal or greater value.
- 5) **HOW TO ENTER: NO PURCHASE NECESSARY.** During the Contest Period, keep an eye on our social media posts on Facebook and Instagram. To receive one entry in the Contest: (i) tag a hockey lover in the comments; (ii) like, save and comment on the post; and (iii) follow @bostonpizza in the case of Facebook, or @bostonpizzacanada in the case of Instagram. To receive a second bonus entry in the Contest, share the post to your Facebook or Instagram story.
- 6) SELECTION OF PROSPECTIVE WINNERS: On Wednesday, May 7, 2025 at 11:00 a.m (ET) at Unit 4, 85 Prologis Blvd., Mississauga, Ontario, L5W 0G4, a representative of Contest Operator will randomly select one (1) entrant from all entries received on Facebook during the Contest Period to win the Facebook Prize (the "Facebook Winner"), and one (1) entrant from all entries received on Instagram during the Contest Period to win the Instagram Prize (the "Instagram Winner"). The Facebook Winner and the Instagram Winner will each be contacted by the Contest Operator or a representative of the Contest Operator via direct message from the verified @bostonpizza account on Facebook or from the verified @bostonpizzacanada account on Instagram within three (3) days of the selection. If any

potential Facebook Winner or Instagram Winner is unable to be contacted after two (2) attempts, he or she forfeits the prize and another entrant may, at the sole discretion of the Contest Operator, be selected.

The Contest Operator reserves the right to disqualify any individual whom it finds in violation of these Official Rules and Regulations or tampering with the entry process. The Contest Operator reserves the right to refuse an entry from a person whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter.
