(the "Contest")

OFFICIAL RULES AND REGULATIONS

The Contest is intended for viewing and participation in Canada only by legal residents of Quebec, Canada who are at least 18 years of age, and shall be subject to and construed in accordance with the laws of Canada. **Please do not proceed if you do not satisfy these requirements at the time of entry. Entry into the Contest constitutes your acceptance to these Official Contest Rules and Regulations. NO PURCHASE NECESSARY.**

- 1) **ADMINISTRATION:** The Contest is administered and operated by Boston Pizza International Inc. (the "**Contest Operator**"). The decisions of the Contest Operator are final and binding in all matters as they relate to the Contest, including without limitation eligibility and/or disqualification of entries. Molson Canada 2005 ("**Molson**") is a prize supplier only. Molson and its related companies, affiliates and subsidiaries are not responsible for the promotion, administration or execution of this Contest, or the administration, use or misuse of any prize. By entering this Contest, entrants agree to completely release Molson and its related companies, affiliates and subsidiaries from any liability.
- 2) **ELIGIBILITY:** To be eligible to win a prize in the Contest, you must: (i) be a legal resident of Quebec, Canada; (ii) be at least 18 years of age on July 19, 2026; and (iii) not be an employee, contractor, agent or representative of (and not be a member of the immediate families of an employee, contractor, agent or representative of) the Contest Operator, Boston Pizza Canada Limited Partnership ("**BPCLP**"), Molson, or any of their affiliates, agencies, prize suppliers, any franchisee of BPCLP or any of their respective shareholders, trustees, directors, officers, employees or agents with whom such employees contractors, agents and representatives are domiciled. For the purpose of the Contest, "immediate family" is defined as parent or any person residing in the same household or domiciled with any such employees, contractors, agents or representatives.
- 3) **CONTEST PERIOD:** The contest period for a chance to win a Prize (defined below) will commence on Monday, May 4, 2026 at 9:00AM (ET) and will conclude on Sunday, July 19, 2026 at 11:59PM (ET) (the "**Contest Period**").
- 4) **PRIZES:** There will be twenty-nine (29) prizes to be won, each consisting of two (2) one-day passes to the 2026 Osheaga Festival Musique et Arts (the "**Festival**") being held at Parc Jean-Drapeau, Montreal from July 31, 2026 to August 2, 2026 (each, a "**Prize**"). Each Prize will be awarded through a random draw held separately for each of the twenty-nine (29) Boston Pizza locations in Quebec (each, a "**Quebec Location**"), from among all eligible entries received at that Quebec Location during the Contest Period. The day of the Festival for which the one-day passes comprising a Prize will be valid will be selected at the sole discretion of the Contest Operator. The approximate retail value of each Prize is CA\$350. The Prize includes Festival passes only and Winners (defined below) are solely responsible for all additional costs, including but not limited to transportation, parking, accommodation, meals, taxes, and any other expenses associated with attendance. The Prize must be accepted as awarded and has no cash value. The Prize is non-transferable, non-redeemable and no substitution will be made except that the Contest Operator, in its sole discretion, reserves the right to substitute the Prize for a prize of equal or greater value.
- 5) **HOW TO ENTER: NO PURCHASE NECESSARY.** During the Contest Period, scan the QR code provided on the dine-in menus at any Quebec Location to access entry on the Contest website. On the website, follow the on-screen instructions to complete all fields on the entry form. One (1) entry will be made upon completing all fields and clicking submit.
- 6) **SELECTION OF PROSPECTIVE WINNER:** On Monday, July 20, 2026 at 11:00:00 AM (ET), a representative of the Contest Operator will randomly select a total of twenty-nine (29) entrants to win a Prize by drawing one (1) entrant from all entries received during the Contest Period at each of the twenty-nine (29) Quebec Locations (each, a "**Winner**"). If no eligible entries are received at any Quebec Location during the Contest Period, the Prize for such Quebec Location will be awarded to an additional entrant drawn from the entries received at another Quebec Location. Each selected Winner will be contacted by the Contest Operator or a representative of the Contest Operator via telephone and/or email within three (3) days of the selection. If any potential Winner is unable to be contacted after two (2) attempts, he or she forfeits the Prize and another entrant may, at the sole discretion of the Contest Operator, be selected.

- 7) **ODDS:** The odds of winning a Prize are dependent upon the total number of eligible entries received during the Contest Period at the same Quebec Location at which you submit your entry.
- 8) **AWARDING OF PRIZES:** The Contest Operator is not responsible for the failure, for any reason whatsoever, of a selected entrant to receive notification or for the Contest Operator to receive a selected entrant's response. No communication will be entered into by the Contest Operator with entrants except with the selected entrant. In order to be declared a Prize winner, the selected prospective Winner must:
- (a) have entered the Contest in compliance with these Official Contest Rules and Regulations and be eligible to win a Prize pursuant to these Official Rules and Regulations;
