(the “Contest”)

OFFICIAL RULES AND REGULATIONS

The Contest is intended for viewing and participation in Canada only by legal residents of Canada, who have attained the age of majority in the province in which they reside, and shall be subject to and construed in accordance with the laws of Canada. **Please do not proceed if you do not satisfy these requirements at the time of entry. Entry into the Contest constitutes your acceptance to these Official Rules and Regulations.**

- 1) **CONTEST ADMINISTRATION:** The Contest is administered and operated by Boston Pizza International Inc. (“**Contest Operator**”). The decisions of the Contest Operator are final and binding in all matters as they relate to the Contest, including without limitation eligibility and/or disqualification of entries.

- 5) **HOW TO ENTER: NO PURCHASE NECESSARY:** To enter the Contest and to have a chance to win a Major Prize or a Secondary Prize, simply scan the QR code provided in the Boston Pizza Kid’s Menu Booklet that can be obtained at participating Boston Pizza restaurants across Canada (“**Participating Boston Pizza Restaurants**”) or can be found on various advertisements located at Participating Boston Pizza Restaurants and on Boston Pizza’s social media platforms, to access entry on the Contest site at www.bostonpizza.com/nintendoswitch (the “**Contest Website**”). Click on the Contest tab and follow the on-screen instructions to complete the online entry form in full. All fields on the entry form must be completed unless they are otherwise indicated as optional. Limit: one (1) entry per person/email address per day. The Contest Operator is not responsible for lost or late entries or entries that have been tampered. All decisions of the Contest Operator shall be final and shall not be subject to appeal.

6) **SELECTION OF PROSPECTIVE WINNERS:**

for a total of twenty-five (25) prospective Major Prize winners.

Secondary Prizes: On Tuesday, October 1, 2024 at 11:00:00 AM (Eastern Time) at Contest Operator’s office located at 4 – 85 Prologis Boulevard, Mississauga, Ontario, L5W 0G4, Contest Operator will select prospective Secondary Prize winners as follows:

- (a) Three (3) prospective Secondary Prize winners will be selected from all entries received from entrants who supplied an address within British Columbia, Yukon, Northwest Territories or Nunavut;
- (b) Five (5) prospective Secondary Prize winners will be selected from all entries received from entrants who supplied an address within Alberta;
- (c) Three (3) prospective Secondary Prize winners will be selected from all entries received from entrants who supplied an address within Saskatchewan or Manitoba;
- (d) Five (5) prospective Secondary Prize winners will be selected from all entries received from entrants who supplied an address within Ontario;
- (e) Two (2) prospective Secondary Prize winners will be selected from all entries received from entrants who supplied an address within New Brunswick, Nova Scotia, Prince Edward Island or Newfoundland and Labrador; and

- (f) Two (2) prospective Secondary Prize winners will be selected from all entries received from entrants who supplied an address within Quebec;

for a total of twenty (20) prospective Secondary Prize winners.

The prospective Major Prize winners and Secondary Prize winners will be contacted by the Contest Operator or a representative of the Contest Operator via email within seven (7) days of the selection. Parties shall not be liable any damages caused or alleged to be caused by: (a) any entry, Major Prize or Secondary Prize, or other correspondence or data that is lost, stolen, late, garbled, distorted, delayed, damaged or misdirected for any reason; (b) for any failure, interruption, technical malfunction or delay; (c) any communication sent or received to or from the Contest Operator or any of its agents or designees, for any reason; (d) for any incorrect, untimely or inaccurate information, whether caused by users or by equipment or programming errors associated with or utilized in any part of the Contest; (e) for any technical or human error which may occur in the processing of any entry or entries in the Contest; (f) for problems with the function of any website or website feature (including, without limitation any features thereon), howsoever caused; (g) for the malfunction of, or damage caused to, any telephone network or lines, computer equipment, data, software, online systems, servers or access providers; (h) for any functionality lost due to not having cookies enabled; (i) for traffic congestion on the Internet; (j) for the security or privacy of information transmitted via telephone or computer networks; (k) for breaches of privacy due to interference by third party "hackers" or for any damage caused to or incurred by any entrant or any other person by reason of any such event or occurrence; or (l) for printing errors appearing in these Official Rules and Regulations or related Contest materials.

- 10) **SUBJECT TO APPLICABLE LAWS:** Each part of the Contest is subject to all applicable federal, provincial, municipal and local laws. The Contest Operator reserves the right to modify or terminate the Contest, or any portion thereof, at any time without notice to participants. The Contest is VOID WHERE PROHIBITED BY LAW.
- 11) **PRIVACY STATEMENT:** Personal information collected during the administration of the Contest, or any part of the Contest, will only be used in conjunction with executing the terms of the Contest as described in these Official Rules and Regulations. By entering any part of the Contest, each entrant consents to the Contest Operator and its parent companies, subsidiaries, affiliates and agencies, collecting and using the information an entrant provides on the contest entry, including winner's contact information, to qualify the Major Prize winner or Secondary Prize winner for the Contest and to contact the Major Prize winner or Secondary Prize winner and provide ongoing service regarding the same.
