

Boston Pizza® x Guinness® St. Patrick's Day Giveaway Contest (the "Contest")

OFFICIAL RULES AND REGULATIONS

The Contest is intended for viewing and participation in Canada only by legal residents of Canada (excluding residents of Alberta) who are at least 19 years of age, and shall be subject to and construed in accordance with the laws of Canada. Please do not proceed if you do not satisfy these requirements at the time of entry. Entry into the Contest constitutes your acceptance to these Official Contest Rules and Regulations. NO PURCHASE NECESSARY.

- ADMINISTRATION: The Contest is administered and operated by Boston Pizza International Inc. (the "Contest Operator"). The decisions of the Contest Operator are final and binding in all matters as they relate to the Contest, including without limitation eligibility and/or disqualification of entries. Diageo Ireland Unlimited Company ("Guinness") is a prize supplier only. Guinness and its related companies, affiliates and subsidiaries are not responsible for the promotion, administration or execution of this Contest, or the administration, use or misuse of any prize. By entering this Contest, entrants agree to completely release Guinness and its related companies, affiliates and subsidiaries from any liability.

To enter: (i) tag a Guinness lover in the comments, (ii) like and save the post, (iii) follow @bostonpizza on Facebook, and @bostonpizzacanada on Instagram, and (iv) share the post to your story for a bonus entry.
- SELECTION OF PROSPECTIVE WINNERS: On Wednesday, March 26, 2025, one (1) entrant will be randomly selected from all entries received on Facebook during the Contest Period to win the Facebook Prize (the "Facebook Winner"), and one (1) entrant will be randomly selected from all entries received on Instagram during the Contest Period to win the Instagram Prize (the "Instagram Winner"). The Facebook Winner and the Instagram Winner will each be contacted by the Contest Operator or a representative of the Contest Operator via DM from the verified @bostonpizza account on Facebook or from the verified @bostonpizzacanada account on Instagram within three (3) days of the selection. If any potential Facebook Winner or Instagram winner is unable to be contacted after two (2)

attempts, he or she forfeits the prize and another entrant may, at the sole discretion of the Contest Operator, be selected.
